WORK CARD APPEAL

25. <u>REQUEST TO APPEAR BEFORE CITY COUNCIL SUBMITTED BY TAMMY</u> <u>RODRIGUEZ TO APPEAL THE DENIAL OF HER GAMING WORK PERMIT.</u>

Detective Brad Walch stated he had received a request for a Gaming Work Permit from Ms. Rodriguez. A background check was completed where it was discovered that she had been arrested for possession of a stolen vehicle that had subsequently gone to warrant. She was arrested in 1999 and was again arrested in January 2001 for the felony offense. Ms. Rodriguez had pled in court to a gross misdemeanor. Mayor Pro Tempore Robinson questioned if she was arrested twice on the same warrant. Detective Walch responded that was correct; she was arrested for the same charge of possession of a stolen vehicle.

Ms. Rodriguez stated she had been apprehended while the car was parked outside a store. She was asked by a police officer if it was her car and she responded it was her daughter's friends' car. The officer informed Ms. Rodriguez that the car was stolen. Mayor Montandon stated whether the car was stolen or not was not the issue. Before Council was the fact that Ms. Rodriguez was found guilty of a gross misdemeanor. No evidence could be heard by Council to support her claim of innocence. Ms. Rodriguez stated she was offered a job at the Silver Nugget and when she went to apply for her Sheriff's card she learned it was denied because of her conviction.

Mayor Montandon questioned where the application would go if it were approved by Council. Detective Walch stated the State would review the application and according to State Statute, if she were found guilty of a felony or a gross misdemeanor, she would be disallowed the privilege of a gaming work card. Mayor Montandon stated although Council had the authority to determine if Ms. Rodriguez obtained a work card, the approval may be overruled by the State. Mayor Montandon was not in favor of granting a work card that would be denied at the State level.

Mayor Pro Tempore Robinson asked if it was an automatic denial at the State level if there was a felony or a gross misdemeanor conviction in an applicant's past. Detective Walch stated it was not an automatic denial and it was possible the case would not be reviewed at all. If the case were reviewed, Detective Walch stated there was a good possibility it would be denied as well.

City Attorney Sean McGowan re-emphasized there was concurrent jurisdiction with the City and the State. Each jurisdiction had the ability to grant or deny the work permit based on the City's evaluation of the applicant's suitability to hold the permit. It was at the State's discretion to review the case or not following the City's action.

Mayor Montandon asked Ms. Rodriguez if in 1999 she was found with a stolen car and was arrested again on the same issue in 2001. Ms. Rodriguez stated when she was arrested the first time, and she did not make her court appointment so the case went to warrant. She did not pursue the matter until she was found by the police a year later when she was again arrested.

Mayor Pro Tempore Robinson questioned if there were any other charges against Ms. Rodriguez that would give some reason to not issue the work permit. He felt all persons needed gainful employment and should be given a second chance. Detective Walch stated there was a record behind Ms. Rodriguez but she disputed the accuracy of the records. She felt there was another individual with her same name but a different middle initial and those charges belonged to that person.

Mayor Montandon asked Ms. Rodriguez if she was aware the car had been stolen. Ms. Rodriguez responded she did not know it was stolen and that her daughter's friend that gave her the car had been arrested for stealing cars.

Councilwoman Smith commented it was difficult for her to evaluate a person when she could not see them. She stated she would be abstaining from the vote.
