Councilwoman Smith questioned if it was possible to place a requirement in the resolution that the money be spent in North Las Vegas. Community Development Director Jacque Risner felt it was possible to include that language in the resolution. City Attorney McGowan stated he knew of no legal requirement for stipulations in the resolution.

Mayor Montandon commented it was unfortunate that with the first priority of the bond state ceiling being that of job creation, year after year no companies other than the public utilities applied for it. He stated Southwest Gas would acquire bond cap ceilings from numerous entities in the State and the funds would be pooled together into their capital projects. He felt Southwest Gas spent at least the bond cap, if not more, for improvements in North Las Vegas.

Community Development Director Risner suggested requiring Southwest Gas to report back to Council the percentages of funds expended in North Las Vegas.

4. APPROVAL OF A SETTLEMENT CLAIM BY CELSO PAZ LOPEZ, IN THE AMOUNT OF \$500.000.

**City Manager Kurt Fritsch:** 

Item No. 4, approval of a settlement claim by Celso Paz Lopez, in the

amount of \$500,000. Mr. McGowan.

City Attorney Sean McGowan:

Thank you, Mr. Fritsch. Mr. Mayor and Council, before I get to the facts of this case I would just like to say that as a philosophical approach to these matters I, I hope that you have seen and maybe it's not apparent to the public yet, but that what we have tried to do in the 18 months that I've been in this position is to bring an aggressive defense of the City's interest to bear; both the legal and financial interest of the City. We want the message out there that there is no easy money to be made here. Our claims are down, way down from the year just completed, down about \$350,000 from claims paid in the second preceding fiscal year. So I think along with Kurt's team and especially Dwight Rawlinson in Risk Management Department we've made some great strides in reducing claims paid in settlements; savings of about \$350,000. And doing it at \$80,000 less in outside of attorneys fees. So we've - - we think we're on the right track, but there are always are cases that are exceptional and this is one of them. There are some, some clouds on the horizon. As to this case, according to the standards established by the United States Supreme Court, a police officer may only use deadly force if the officer has probable cause to believe that the suspect poses a threat of serious physical harm either to the officer or to others. Now we looked at this very carefully and very long with outside counsel as well, and we're recommending this settlement because we believe that after hearing the evidence a jury would ultimately get to hear this and make factual determinations and would more likely than not conclude at the time of shooting, Mr. Lopez posed no objective threat to the officer because he was on his stomach and being handcuffed. We believe that

a jury would likely conclude that Officer Acosta's version of the events that Mr. Lopez had a grasp of the weapon barrel is just not credible. We also believe that there - - a jury would conclude that Officer Acosta could not have lost the weapon to Mr. Lopez because it was strapped across Officer Acosta's chest. Finally we think a jury would conclude that this shooting was accidental. Mr. Lopez ultimately complied with officer's demands and he produced his second hand, the right-hand to be cuffed and in the process may have touched or bumped the rifle barrel causing the officer to move backwards, bump into another officer and accidentally shoot Mr. Lopez. So these, these are comments made for the purposes of settlement discussions we think that there are risks in taking these facts to a jury. We'll do so if the Council would like and we'll do our best job possible, but we think it is important to exercise our professional judgment and bring to your ecommendations for settlement when there are risks in proceeding to trial in such a case. There will be other cases that we can defend and there are a couple of other shootings that have occurred in which you can anticipate vigorous defense of the officer's conduct, but we don't believe this is one such case. And for those reasons we're recommending the settlement.

# **Mayor Michael L. Montandon:**

Thank you Sean, I appreciate it. I don't believe I'm speaking only for myself in saying that decisions like this are extremely difficult for the City Council when, you know, writing half a million dollar checks or at least discussing the possibility of doing so when, when so many other good places for half a million dollars are at stake. However, you know we're, we're faced with this decision and it is our job to take the facts into account from the best possible legal advice we can get and decide as a City Council what the best road to take is, and right now, given this we are faced with the advice from our City Council - - our, our legal counsel to go forward with a settlement of this case. We can debate those issues and facts but the question is whether or not, given what we already know, we want to put Mr. Paz Lopez through that public debate also in return for what most likely would not be a case this City has a leg to stand on. So given that I would like to know if any of the other - - I do have a couple of cards from people who would like to speak. If any of the other Council would like to speak on this issue, Councilman Buck.

# **Councilman Shari Buck:**

A question just for Sean. Legal fees from my understanding it was determined if we were to go to trial that legal fees would probably exceed an enormous amount?

# **City Attorney McGowan:**

We - - we would have counsel for the City, we would have separate counsel for Officer Acosta, and if the claimants of Mr. Lopez were found to be entitled to any compensatory damages, which we think is likely to

be the conclusion of a jury, and since he has substantial medical bills to reconstruct his digestive tract, the - - yes, there would be substantial legal fees we think could easily be three hundred to three hundred and fifty thousand dollars to defend this case in a likely jury verdict based on the conclusions that I suggested are more likely than not. A jury verdict, without regard to the fees would - - could easily be six fifty to seven fifty. So, I think it is a reasonable possibility that a trial could result in total cost to the City of a million dollars or more.

**Mayor Montandon:** 

Thank you. Councilman Robinson.

Mayor Pro Tempore
William Robinson:

Thank you, Your Honor. I have a question and comment. My question is have we put anything into place hopefully to avoid problems of this sort because we're not talking about chump change so to speak, we're talking about quite a bit of tax, we're talking about half of million dollars of taxpayers dollars and I have a problem with it because I, I tend to believe that even though an officer was wrong, the person that was shot wasn't a saint themselves otherwise I don't think the officers would have responded; however, be that right or wrong, have we done anything to make sure this type of shooting don't happen again by our Police Department?

**City Attorney McGowan:** 

Yes Councilman, you as a group have been supportive of the need to do more proactive work in this area. You've authorized an additional position in my office to work with the police on training matters and policy changes so, so we are working hard to find areas that need to be addressed in advance. Having said that of course, we will never unfortunately be able to avoid every mistake in a high-stress dangerous position - -

<u>Mayor Pro Tempore Robinson:</u> Yeah, I'm conscious of that.

<u>City Attorney McGowan:</u> - - but I think we're doing what we can and with your support on

additional proactive legal advice we're certainly giving it our best shot.

Mayor Pro Tempore Robinson: So then I guess the comment would be in spite of how much I feel that I

should vote against this, I guess the bottom line is cut your losses and

go home.

<u>Mayor Montandon:</u> Thank you. I've got some cards, Mike Winne.

Mike Winne: Mike Winne, 3005 Emmons. A few questions and a couple comments.

Was this shooting ruled unjustified?

<u>Mayor Montandon:</u> Sean.

<u>City Attorney McGowan:</u> We have to this point maintained as a City policy that the results of the

internal affairs investigations are not disclosed.

Mike Winne: Well, that question, there was an article in the paper today where all this

information was seemed to be disclosed to the King County administrators up there and I just - - my curiosity would be why can't the

public know about it?

<u>Mayor Montandon:</u> The results of their internal investigation, the King County Police

Department has considered the public they've got the same information

everybody else does.

Mike Winne: According to them they didn't. Ok, the next question I have is, if we pay

him this money is this all that we owe him or are there going to be

ongoing medical cost?

<u>Mayor Montandon:</u> No it would be a complete and final settlement.

Mike Winne: Ok, then what I would like to formally request; I would like to formally

request, excuse me - - that I be given an itemized list of any and all the attorney expenses that we have, we have - - us citizens have incurred due to this case. I would also like to have the tax money that we've paid out in medical bills to this date. If we paid out medical bills. So then after we're done, we're not going to owe any money, is that correct?

Mayor Montandon: Right now what's before the Council is an approval to offer a settlement

of \$500,000.

Mike Winne: And if that's approved - -

<u>Mayor Montandon:</u> This - - if this - -

**Mike Winne:** -- that's the end of it.

<u>Mayor Montandon:</u> I'm talking. Ok. When the - - we have before us an approval to an offer

a settlement of \$500,000. The settlement has not been drafted yet. If we approve to offer a settlement it will then be the City Attorney's job to go forward and negotiate a settlement with them for \$500,000. A complete,

total, end of everything settlement.

Mike Winne: Ok. That will lead me to the next issue that I have. The next issue that

I have is many of you know that Dave Acosta is now a King County

Sheriff Deputy and he is now another police officer. And the problem that I have is that is that he was allowed to resign. He was given an option to resign or be terminated which I believe now leaves the City open to precarious liability lawsuit. If he shoots, maims or kills another person in King County. Dave Acosta himself told us that he was given a letter of resignation and was given the option of resignation or termination during a conversation with him at UMC Hospital.

<u>Councilman Buck:</u> He told you that specifically, Mike?

Mike Winne: Yes.

Councilman Buck: Ok.

Mike Winne: Yes, that was discussed. And due to the fact Mr. Acosta was allowed

to resign and a letter of reference was given which allowed Mr. Acosta

to practice law.

<u>Mayor Montandon:</u> You say a letter of reference was given?

Mike Winne: Yes, by Chief Tillmon that was what Dave Acosta told us. There was --

Councilman Buck: Who - - excuse me, who's us?

<u>Mike Winne:</u> There was another person there with me. That person can give their

name if they want. I'm not going to give that person's name. The reason I believe this is because Dave Acosta was involved in four shootings in

five years.

**Councilman Buck:** And how do you know that?

Mike Winne: Well, it's Dave Acosta himself. Ok. Are you saying that it's not

happening?

<u>Mayor Montandon:</u> We're asking, we're asking you questions.

Mike Winne:

I know that to be a fact. The first one, there was over behind the Opera

House, there was one over behind McDonalds, and there was one over by the Roland White Chapel and then this one it was involved over off of Soledad; four since 1995. In most of those, Dave Acosta has spoken about how the officers - - how the suspect have grabbed for his weapon. Seems to be a thing. The problem with the one over behind the Opera House was that the suspect was holding a baby in one hand and a gun in the other and threatening to kill himself, so I guess my question would

be, what hand was he grabbing the weapon with?

**Mayor Montandon:** 

That issue is not before us right now.

Mike Winne:

Ok, so let me move on to this. More than likely we're going to be facing another lawsuitdue to this, this case. What the problems comes, is that, it seems that and I've been through this with you before that what happens is we would much rather try to cover up than uncover crimes that are committed by our Police Department. Dave Acosta should never have been given an offer of resignation or termination. He should've been disciplined and punished; prosecuted. There was an unjustified shooting, some say an accident, some say not. But because of that we're going to face, we're going to face another, another liability case. We seem to cover up things. Billy Brooks beats up a woman, we cover it up. And how do we that, we have police officers in the department that help cover it up which - -

**Mayor Montandon:** 

Ok, Mike at this point here if you've got specific accusations or problems to make - - this is not forum to bring it to. Write them down, bring them to the City Manager don't bring it forward right now.

Mike Winne:

Well that - - that's the problem your Honor, is that I have brought these accusations to the City Manager and nothing's happened.

**Mayor Montandon:** 

And you know what, we investigate these appli - - these, these, and you're not satisfied so you just say them again.

Mike Winne:

I don't know if it's ever been investigated the problems that just keep perpetuating. But here's the, let me get to the final resolution here. This is a for action item, it's on the agenda, which means a motion can be made from the floor under Roberts Rules of Orders. It has happened at this Council before, I've made them and all I need is a second from any member of the Council to make a vote. Will Robinson was here when I made that, the rest of you were not. And so what I would like to do is I would actually like to make a motion from the floor.

**Mayor Montandon:** 

I disagree, I have to ask a point of order. I've become actually quite well versed in Roberts Rules of Order and I have - - and I do not have any knowledge of what you're talking about, motions need to be made by the City, this City Council.

Mike Winne:

Well under an action item, I know that I've made motions before. Will Robinson was involved in that, so was Theron and Paula and Jim Seastrand, and those - - and they brought to Council.

**Mayor Montandon:** 

As Chairman of this meeting unless legal counsel tells me otherwise, I'm not going to accept motions from anybody other than this City Council.

Mike Winne:

Ok well then let me ask you to make the motion, which that I can do also. And my motion is this, it's very simple, it solves the problems. The first thing we need to do is I would like to you to make motion to create a task force, using an outside prosecutor to come and look at allegations of criminal activity within the Police Department.

**Councilman Buck:** 

Would you also be willing to look at former employees who are - - um

**Mayor Montandon:** 

If I were to make the task force I would assign specifically what it was going to do. If, if, if

Mike Winne:

That's, that's, that's part of the motion too. Also, that immediately that the City Council would vote and create a citizens review board that would - - and there are certain rules that I have that, that I would like to have on the way people are picked on the review board that no appointments made politically, stunts with a lottery system, no relatives of political people, etc, etc, etc., and the final thing is that I'd like the motion also to contain, that any funds that we pay out to this should come directly from the operating budget of the Police Department. I understand you have a Contingency Fund, pay them out of the contingency, but next year in the fiscal year, take the money directly from the Police Department of their operating budget and put it back into the Contingency Fund. They need to understand that this is not gonna happen. You say we've created all these programs to - - or Mr. McGowan says we created these programs to see that this doesn't happen again. Not one of them involves the citizens, not one of them. Not one of them involves a task force to look into past and present allegations - -

Mayor Montandon:

Actually, I disagree, all of them involve the citizens.

Mike Winne:

No, not as a direct as, as, as a review board, or as an oversight. Their not involved in any of that. We have 194 programs and not one of them, not one of them has been created to look at allegations within the Police

Department.

<u>Mayor Montandon:</u> Everything that involves this City Council involves the citizens, we are

citizens.

Mike Winne: You are citizens. I agree with that. But there's not - - there's no, there's

no task force - - there's no review board - - we went through this three months ago where I know several people on the Council agreed that, yeah, a task force or a review board is needed and no movement on it, other than Chief Tillmon going around talking to people like Bob Borgersen to see if he'll sit on it. Why is the Chief going around trying

to stack a board?

<u>Mayor Montandon:</u> Your recommendations have been noted. Thank you.

Mike Winne: Thank you.

**Mayor Montandon:** Mike Thomas.

Mike Thomas: Mike Thomas, 8398 San Ramon. I have also some statements, some

questions, and some comments. Um. One of things I seem to notice most as of late in most of the City Council meetings, we have a lot of distinguished departments head, heads here, but we never seem have a Chief of Police here when most of the time we seem to be talking about police issues and I was just wondering why that was before I get

into what I want to get into.

<u>Mayor Montandon:</u> There's always a representative from the Police Department.

Mike Thomas There wasn't at the last meeting, but that's neither here nor there. As it

was pointed out to me by several other department heads. I've got a

couple questions, does the City carry general liability insurance?

<u>Mayor Montandon:</u> We're self insured.

Mike Thomas: Ok, so that means any money paid out in any settlement, any litigation

comes from the operating budget, taxpayers money, is that correct?

<u>Mayor Montandon:</u> It's from our self insurance fund, yes.

Mike Thomas: Well, you can say this is money allocated for self insurance fund but it's

still taxpayers money?

**Mayor Montandon:** Yes, of course it is.

Mike Thomas: All right. Um, sounds like what Sean's talking about here is some fiscal

responsibility that he has to make sure that costs are always in the best interest of the City and that there is no easy money to be made here, he says, I was wondering why settle with Celso Paz Lopez, has this man

filed a lawsuit against the City of North Las Vegas?

<u>City Attorney McGowan:</u> Mr. Mayor no there is - - has not been a filed lawsuit.

Mike Thomas: Did he filed a lawsuit against David Acosta?

<u>City Attorney McGowan:</u> Mr. Mayor would you like me to answer that?

<u>Mayor Montandon:</u> Yes, please, Sean, thank you. I apologize.

**City Attorney McGowan:** Not to my knowledge, no this would affect a complete and full release of

the City and Officer -- former Officer Acosta.

Mike Thomas: Ok, so essentially your kinda putting on the cart before the horse without

knowing how strong this gentleman's case is, who his legal counsel is, and what he's filing in any court of law, you're ready to propose a

settlement, correct?

<u>Mayor Montandon:</u> Actually, quite the opposite. You just heard Mr. McGowan give a fairly

detailed description of how strong he feels this case is. He does have

counsel. We know who his counsel is. So quite the opposite.

Mike Thomas: Ok then I think that in light of that it sounds to me that also Mr. Gowan is

saying that he has no confidence in how the North Las Vegas Police Department handled this incident, how it was investigated and he does not believe that this case is winnable to go before a jury is that what I'm

hearing?

<u>Mayor Montandon:</u> You heard what you heard it's speculation in between the lines you're

welcome to interpret however you would like.

Mike Thomas: Ok, I read an article in the Las Vegas Review Journal today that the

representatives, the detectives from the King County Washington

Sheriffs Bureau came out here, they were given details of the incident. I'm sure their reasonable and intelligent people and they concluded that Dave Acosta shooting was justified based on the information that they had. Are we saying that a jury might be any less intelligent or less reasonable?

<u>Mayor Montandon:</u> That was their determination.

Mike Thomas: Ok.

<u>Mayor Montandon:</u> We can't, we can't judge them. Anything else?

Mike Thomas:

Ok, then I guess my final thought would be I believe, I truly believe that there was fraud perpetrated on the King County Sheriff's Department. The reason being is when they say they were given documentation they were given the cleaned up, sanitized version. They were given criminal reports prepared by the officers involved in this some two months after the incident. The King County officials said they were not aware of any shooting board findings, they were not given the testimonies of people involved in the shooting board, they were not given the exhibits, the evidence that was presented on the shooting board, and we know this to be true because they said, they were not given that information. And I think it speaks - - it screams out that Dave Acosta has been involved in four shootings in five years, three of which he claims somebody was reaching for his gun. I think that, that is a major problem. And I would only emphasize I think that the speaker before me is absolutely correct. If you look at the amount of lawsuits being generated against the City of North Las Vegas and we're not talking employee, or ex-employee lawsuit, we're talking lawsuits in and of themselves. The majority of them are against the Police Department and I think that the Police Department as long as they are not footing the bill and they don't have to take responsibility for their action because nobody - - somebody else is going to reach into their wallet to pay the bill ultimately, they will continue to go about their merry way. I think that the money needs to come from the operating budget; I think we need to re-examine their protocols, their procedures and their training. I would venture to guess that the King's County representative were never given the memos from Dave Acosta where he talks about the lack of training and the poor training. And he talks about how the officers were not given the adequate training to respond to an incident like he did. So I would just emphasize like I said, you're punishing the citizens when you need to be

punishing the Police Department. Thank you.

<u>Mayor Montandon:</u> Thank you. Glen Easter.

Glen Easter: Glen Easter, 4715 N. 5<sup>th</sup> Street. I'll just make this guick. I'm for this, I

think this is the greatest thing in the world that could happen to our City. Citizens will finally see what's going on. What I would like to ask is that you put this on the Consent Agenda, meaning that had not citizens brought this off and taken it off the Consent Agenda, we would've never

gotten an explanation - -

Mayor Pro Tempore Robinson: I disagree with you Mr. Easter.

**Councilman Buck:** What citizen took it off?

**Glen Easter:** When they put in the cards.

Councilman Buck: No.

<u>Mayor Montandon:</u> No I took it off. I disagree.

Glen Easter: Well then why - - ok why was it put on the Consent Agenda in the first

place?

<u>Mayor Montandon:</u> Because our standard policy is settlements are put on the Consent

Agenda.

**Glen Easter:** Because my big problem here is that I think it's great. We spend a half

million dollars; we can't see what happen. If we did shoot this guy illegally I don't think half a million dollars is enough for him. They have the guy having his digestive tract reconstructed. And if we didn't do anything wrong we should defend our police and stand up for him whether -- and if not we just condemn this City to what we are, second

class City by not giving to the truth. Thank you very much.

<u>Mayor Montandon:</u> Thank you. Council any other comments or questions? What is your

desire?

**Councilman Buck:** I just want to a make a comment if I might Your Honor.

<u>Mayor Montandon:</u> Councilman Buck.

And I think we hired Sean McGowan to provide us with the legal expertise that none of us possess and in spite of my being against paying one cent, that you - - what was that old country song that you got to know when to hold them and when to fold them, so my - - I'm going to motion that we approve the settlement of the claim by, how do you pronounce that, Cel, well Lopez, in the amount of \$500,000, and hopefully we - - this doesn't happen again. And that's my motion.

Councilman Buck:

I'll second it.

**Mayor Montandon:** 

Thank you. Cast your votes. Motion carries. We've often discussed the possibility of televising our City Council meetings. We normally decided not to do that because of the expense of it. This was a very expensive City Council meeting to televise. But we thank you from the various media out there for being here.
