Stations Casinos Inc & Blake & Delise Sartini Family Trust
 <u>DBA</u>: Southwest Gaming Services, Inc and Texas Station Gambling Hall & Hotel

The Trust will acquire 100% of Southwest Gaming Services, Inc., which is currently a wholly-owned

subsidiary of Stations Casinos Inc (STN's). The transaction will be accomplished by the Trust exchanging a certain number of shares of STN's common stock that it owns for all the common stock of Southwest Gaming that STN's owns.

<u>Certain provisions must take place to comply:</u> Both entities in a stock exchange must be engaged in an active business, before and after the exchange. Southwest has been and continues to be an active business, however, Stations Casinos Inc (STN's) is a holding company and has no active business operations. To accomplish this goal, STN's wholly-owned subsidiary, Texas Station Inc., the current operator of Texas Station Gambling Hall & Hotel, will merge into Texas Station, LLC, a Nevada limited liability company which is also wholly-owned by STN's. Texas Station, LLC, the surviving entity, will then be the operator of Texas Station Gambling Hall & Hotel.

City Attorney McGowan added because of the confidential nature of disability claims, the cause and medical condition could not be disclosed as well.
