Mayor Montandon opened the Public Hearing.

Acting Development Services Director Jim Stubler explained at the meeting of March 27, 2002, the Planning Commission considered and did not reach a super-majority vote on the proposed amendment. Staff had recommended denial because the request did not comply with the Comprehensive Plan in that convenience commercial areas should only occur at major intersections where neighborhood commercial areas were planned. Convenience commercial areas should not exceed more than three acres at any intersection. The project in question consisted of approximately five acres. Director Stubler pointed out when developed in areas where surrounding development had not taken place, convenience commercial areas might result in a substantial increase in calls for police services. Therefore, convenience commercial areas should not take into account approximately 130 acres one mile to the north of the subject site that was recently zoned as commercial. Staff recommended denial of the application.

**Bob Gronauer, Kummer, Kaempfer, Bonner & Renshaw**, represented the applicant. Mr. Gronauer pointed out this was the first application for convenience commercial presented to Council since the inception of the Comprehensive Plan. He felt the location was perfect for the proposed use. While the gross acreage of the project was approximately 5 acres, once all of the dedications were subtracted, the net acreage was approximately 3.4 acres. He felt the site was uniquely suited to commercial use and was not suitable for a small residential development.

Mr. Gronauer pointed out the site would not be developed with a large anchor tenant. The large commercial development to the north would be for that purpose. This site would house a convenience store, a drug store, a bank or fast food restaurant. It was the applicant's intent to meet or exceed the design criteria for commercial development. There would be over thirty feet of landscaping on the corner of North 5<sup>th</sup> Street and Ann Road. Mr. Gronauer pointed out the Focus Commercial Group had their own set of commercial design standards that would be given to the proposed tenants.

Councilman Eliason stated the City was fortunate to work with a developer such as Focus Commercial Group. He questioned if the three acre site could be a strip center. Acting Director Stubler stated not under convenience commercial zoning. Councilman Eliason voiced his concern the area might be turned into a strip center with short lived tenants. Director Stubler stated the current design guidelines prevented that type of development but it was always a possibility of have tenants come and go with frequent vacancies. Mr. Gronauer stated it was a better use to break the parcel up into pads rather than strip development.

Councilman Buck stated she had recently looked at a office/mini-storage project being constructed at the southeast corner of Martin Luther King Boulevard and Alexander Road. She commented the landscaping was aesthetically pleasing and felt a small development such as the one proposed could look very nice and serve a purpose in the community. Councilman Buck stated she was in support of the project.

Mayor Montandon opened the Public Hearing.

Acting Development Services Director Jim Stubler explained at the meeting on March 27, 2002, the Planning Commission considered and recommended denial, by a 3 to 2 vote, of the proposed amendment to the Comprehensive Plan for approximately 5.6 acres. The applicant also submitted an item for reclassification (Item No. 9) from R-1 Single Family Residential District to a C-P Professional Office Commercial District. That item was also recommended for denial by the Planning Commission. The property to the south had a Comprehensive Plan land use designation of Office. In addition, on February 6, 2002, the City Council approved Ordinance No. 1589 (ZN-60-01) to rezone the property to the south to C-P Professional Office Commercial District. On April 4, 2001, the City Council approved tentative map T-865 for a 260 lot subdivision to the north and west of the subject site. At that time, the property in question was not included as part of the residential subdivision. There was a fault running through the property and it would be difficult to design singlefamily residential lots around the fault. Because of the location of the fault, it was not anticipated the subject site would develop as a single family development. Therefore, the proposed land use and zoning would be appropriate at this location. Staff recommended Council overturn the Planning Commission's denial and approve the subject Amendment to the Master Plan and associated reclassification application.

<u>Mark Jones</u> concurred with Staff's recommendations and stated the design complied with all City commercial guidelines. The plan included intense buffering from the residential portion of the project both vertically and horizontally.

# 30. <u>DISCUSSION AND/OR ACTION REGARDING THE PLANNING OF A CITYWIDE</u> <u>FALL EVENT FOR 2002.</u>

Assistant to the City Manager Brenda Johnson explained Director of Parks and Recreation Director Ken Albright had met with Council members to discuss options for a fall event. Last year, the International Taste of North Las Vegas drew approximately 15,000 people to the City. Since the event would not be occurring this year, Council requested Staff research a City sponsored event in the fall or spring. Ms. Johnson stated Staff was requesting information on the following topics: target audience, size of event, location, budget, theme.

Mayor Montandon requested an event in late fall that would duplicate the success of the International Taste of North Las Vegas. Councilman Buck stated the success of the previous event was because of the large number of citizens participating and assisting the steering committee and the City. One of the goals should be to involve as many citizens as possible as well as invite members of the steering committee that wished to participate. Partnering with the Chamber of Commerce was also an important consideration to make the event a success. Councilman Buck stated her desire to see the event in the same location as the International Taste of North Las Vegas; in and around the downtown area

and City Hall. It was an important location to bring the residents from the newer areas to the downtown area to see what it had to offer. She felt the scope of the event should initially serve the residents of North Las Vegas. Councilman Buck felt the Chamber of Commerce could assist the City with the theme and the budget as well as gaining the support and participation from the non-profit organizations. Councilman Buck stated an annual event was important to bring the community together, even if it could not be on the scale of the International Taste of North Las Vegas.

Councilwoman Smith agreed an event was important for the residents of the City but it was equally important to allow Staff to plan the details. She was in favor of an event at a park or the golf course.

<u>Willie Fields, President of the North Las Vegas Chamber of Commerce</u>, welcomed the opportunity to partner with the City. He stated events such as the Christmas Parade, Balloon Races, as well as the International Taste of North Las Vegas enhanced the image of the City. He stated the details of the project could be determined by a small committee. He felt the financial aspect of the project should be under the control of both the City and the Chamber.

**Mike Winne, 3005 Emmons, North Las Vegas**, felt a City wide event was a good idea. He suggested a street fair theme. Mr. Winne commented his organization, Helping Hands of North Las Vegas, had participated in the International Taste of North Las Vegas and felt the event was cost prohibitive. The issue of using tickets rather than money was an issue for the public. Also, Mr. Winne stated the booth charges were excessive, there were items that were exclusive to the steering committee such as water, and the steering committee took 30% net for food. While non-profit organizations did not have to pay, many vendors were not willing to participate with those restrictions.

Mayor Montandon stated last year's event was a learning experience. He recommended the event be held in spring while the weather was relatively cool.
