25. <u>APPROVAL TO ADOPT THE SOUTHERN NEVADA WATER AUTHORITY'S DROUGHT PLAN, A SUPPLEMENT TO THE 2002 WATER RESOURCE PLAN. (CNLV CONTRACT NO. C-5330)</u>

City Manager Kurt Fritsch stated Clark County, the City of Las Vegas, City of Henderson, the Southern Nevada Water Authority (SNWA) and the Las Vegas Valley Water District had adopted the Drought Plan. City Manager Fritsch introduced Ken Albright, Director of Water Resources at Southern Nevada Water Authority who presented the Drought Plan.

Director Albright stated for the last three consecutive years the runoff from snow melt had been below normal to severely below normal. The snow melt was responsible for maintaining the water levels in the Colorado River Basin. The drought was affecting Denver reservoirs also. Lake Powell storage had been 88% full in January 2000 and by February 2003 had fallen to 54%. The water level at Lake Powell had dropped 65 feet. Lake Mead storage had been 96% full in January 2000 and by February 2003 had fallen to 65%. The Las Vegas Bay Marina had been moved six miles from its original location due to the decreased water level at Lake Mead. The "bathtub ring" effect could be seen against the canyon walls of Lake Powell and Lake Mead. The level of precipitation from rain and snow fell in a negative category for the Colorado River Basin area.

The SNWA Drought Plan would be a three stage plan. Stage one being drought watch, the current stage, the second stage was drought alert, and the third stage was drought emergency. The guiding Drought Plan principles would avoid restricting non-consumptive uses unnecessarily which included indoor uses. The SNWA intended to preserve jobs and avoid tactics that could levy substantial impacts on the community's economic interests. The focus would target reducing consumptive uses which included outdoor uses. A large amount of water was lost each year because it could not be returned to the sanitary sewer for

treatment and release into Lake Mead for reuse. The businesses which used large amounts of water such as golf courses would be placed on a water budget and the use of mist cooling systems would be limited.

Director Albright stated the major demand reduction tools would include restricted seasonal watering schedules, temporary water surcharges, temporary landscape development restrictions, conservation plans and goals for parks, schools, and government facilities. Restricted seasonal watering schedules would be enacted. Watering would be allowed any day, May through August within a certain time of day. Watering every other day from September through October and one time per week from November through February. Watering would be permitted every other day from March through April. He stated the extraordinary conditions caused by the continued drought called for extraordinary measures.

The temporary water surcharges would affect the upper tiers of water usage and may be specific for each water supplier. The surcharges would be expected to create incentive for more aggressive management and efficiency upgrades.

Director Albright stated the landscape development restrictions under the stage of drought watch would include no ornamental turf in new non-residential development. The stage of drought alert would call for no new turf installed in residential yards. Backyards would be limited to a landscaped area of 50% percent. Multi-family residences would have a turf allowance of 50% under non-drought condition and the planting of cool-season turf would be prohibited beginning in May and ending in August.

Director Albright stated supplemental demand reduction tools allowed for car washing that drained into the sanitary sewer or ten gallons allowed per vehicle. The use of fountains would be limited. Rebate incentives would be increased. He stated the money paid for landscape conversions had increased from \$.40 to \$1.00 per square foot for the first 50,000 square feet and \$.50 for additional footage to a maximum of \$300,000. Programs which offered educational outreach and information which concerned waste water would be emphasized.

Councilman Eliason questioned which grass would most be water efficient. Director Albright replied bermuda grass would be more water efficient. Councilman Eliason asked if a mandate to plant water efficient grass could be adopted. Director Albright stated each political entity could take appropriate action.

Councilman Buck stated she supported the Drought Plan but did not agree with all of the plan's proposals. She stated discussions would take place in the future on how to individualize the City's water conservation effort.

Mayor Montandon asked what would be the yearly monetary savings for an average sized

yard of approximately 1,500 square feet by removing the fescue grass and planting bermuda grass which could be over-seeded with rye during the winter. Director Albright stated he did not feel he could offer an answer on a comparison of fescue grass and bermuda grass.

Councilman Buck stated the City would set an example for conserving outdoor water for the citizens since the residents would be asked to conserve outdoor water use. The City would investigate replacing turf with drought resistant plants.

Councilwoman Smith questioned how swimming pools affected outdoor water use. Director Albright replied swimming pools and grass had the same effect on outdoor water use. The SNWA Drought Plan Committee had decided not to include swimming pools in the Drought Plan because of the hardship which could be enacted upon the swimming pool industry thus affecting jobs. Councilwoman Smith questioned how the fountains would be impacted such as the Bellagio. Director Albright stated the governing board of SNWA would decide the issue. He stated the babbling brook located in front of Thomas & Mack Center could possibly be affected, but small fountains would not have an economic impact on the community.
