Mayor Montandon opened the Public Hearing.

Acting Development Services Director Baxter stated this item was for approximately 32 acres. The Planning Commission approved medium-residential, rather than medium/high-density residential as it was originally advertised. The density was approximately nine dwelling units per acre for this project and was in the form of condominium duplexes. The Planning Commission recommended approval.

**Bob Gronauer, 3800 Howard Hughes Parkway, Las Vegas,** represented the applicant in this matter. He stated the Planning Commission and Staff had recommended approval for this application. Initially, his client requested approval for medium-high density; however,

because the density came in over nine units per acre, they agreed to amend it down to a medium-density category.

A neighborhood meeting was held after this item was recommended for approval by the Planning Commission. The Planned Unit Development application was being introduced and the Public Hearing would be held in two weeks, at which time the application could be reviewed.

**Patrick C. Leary, 3527 Barrel Race Court, North Las Vegas,** requested Council deny the action for medium-density zoning, and revert back to single family units. He purchased his home specifically in this area because it was zoned for single family units. He expressed that medium-density zoning would increase traffic, decrease the property value of his home, increase activity in the development and would negatively impact policing, schools and parks.

Councilman Eliason confirmed with Mr. Leary that he wanted single-family residence, and multiple-family units in the area.

Mayor Pro Tempore Robinson asked how the school district responded to the proposed zoning change, and Acting Development Services Director Baxter stated the school was notified of the zoning change and there were no objections from the school district.

**Roberta Young, 3436 Trotting Horse Road, North Las Vegas,** expressed her disappointment concerning the lack of listening by Council and Staff, as well as the Planning Commission.

She stated the quality of the master plan presented four years ago had changed, and several variances had been granted, which increased the density within the master plan. She commented the quality of buildings should have been ensured by City inspections and code enforcement, as well as the quality of landscaping.

The walled corridor on Valley Drive had led to unenforced speed limits on Valley Road and Rancho Rea Parkway by cars and trucks. These streets were used as a shortcut to Craig Road and Cheyenne Avenue. She further stated poor monitoring of parks, increased crime, and unenforced noise level limits were due to the lack of personnel in the police and fire departments.

She requested four-way stops, speed bumps and/or traffic lights be placed in the Valley Drive area, and that Council revert back to the original master plan designations.

<u>Candy McGlathery, 3508 Trotting Horse, North Las Vegas</u>, stated the residents of Silver Wood Ranch did not want duplex housing in their area. They gathered together three to four

years ago to prevent apartments from being built. Two years ago they agreed to light industrial on and behind the Cheyenne Corridor, and were attending meetings now because plans had changed again. She stated they could not afford increased traffic, crime, and destruction to parks.

She invited Council to meet with residents at Silver Wood Ranch and requested their assistance.

Mayor Pro Tempore Robinson advised the Police Department had been notified about increased speeding in this area and asked that he be notified if there were no reduction in speeding activity.

Mayor Montandon acknowledged the walled corridors between Valley Drive and Rancho Rea Parkway were an issue. He stated walls were no longer allowed to come to the back of the sidewalk and there was a landscape setback on every street. He requested that Public Works look at traffic calming in this area.

Councilman Buck advised there were traffic calming devices at the north end of Valley Drive. She inquired how many notices were sent out to the citizens on this matter and Acting Development Services Director Baxter advised everyone was contacted within a radius of approximately 500 feet.

Mr. Gronauer stated his office worked with neighbors to schedule a neighborhood meeting following the Planning Commission meeting approximately one month ago. They also worked with the Homeowner's Association president, Mr. Bob Evans, and provided them with flyers advising them of the meeting. He stated there was a lot of frustration overall with this property over the years. He and the applicant attempted to address issues within the community and extended as much notice as was possible.

Councilwoman Smith stated the area needed to be examined for accessibility to the residents' homes, as various on-going phases of development might make access difficult.

Mayor Montandon acknowledged that an award was given earlier to the Brennan Brothers for their partnership in the Cheyenne Technology corridor project and he was not comfortable decreasing the size of the Technology Park for residential zoning.

Councilman Eliason asked Mr. Gronauer whether gating this community would be considered. Mr. Gronauer responded he had researched the possibility and discovered this would not be a viable option. Councilman Eliason asked whether or not there was an interest in creating a senior community (ages 55+), and Mr. Gronauer responded no, this option was not considered.

Mayor Pro Tempore Robinson asked Mr. Gronauer whether single stories would be considered and Mr. Gronauer stated the product design was two-story.

Councilwoman Smith commented she favored some types of higher-density zoning if the planning was done well. She noted there were single story homes on the north side of the road and two-story duplexes on the south side of the road, facing each other. She stated she was not comfortable with this.

Mr. Gronauer stated the developer to the north said he thought he would be able to sell his homes with the existing proposal. Councilwoman Smith stated the issue was not whether he could sell his homes, but dealing with the aftermath of poor planning and development.

Mayor Montandon stated Council heard an amendment to the master plan regarding overall density, but they did not have the zoning before them. It was his recommendation this item be held until the accompanying zoning item could be heard, when all information was present.

of the use permit.

City Attorney Sean McGowan asked for clarification. He stated the item was an appeal by the Potlatch Corporation against the approval by the Planning Commission. Mr. Gronauer agreed and stated he represented Las Vegas Paving in this matter. He explained Las Vegas Paving and Potlatch had an agreement, whereby Potlatch would withdraw their appeal if Council agreed to the extension of the use permit to December 1, 2004.

City Attorney McGowan felt it would be appropriate to act on the appeal so the effective date of the appeal would be the current date. The use permit would be effective for one year. He felt Council was being asked to act upon a request that was never considered by the Planning Commission. Mr. Gronauer responded the Planning Commission had approved the application in August to be effective until October. The additional eight weeks to construct the plant had been necessary to comply with Health District requirements regarding air quality. Those eight weeks had been lost due to the appeal process. He requested the eight weeks be granted in addition to the year which was essentially what the Planning Commission approved with only the dates moved forward.

He stated he should not be required to have a permit for a one or two-day garage sale, and the ordinances should state the location of where to receive permits.

Councilman Eliason inquired about quarterly, versus semi-annual yard sales.

Mayor Montandon stated he had a recent opportunity to participate on a television talk show, where people called in to ask about this topic. He asked the callers how long they had lived in the area and how often they had a garage sale or yard sale. Mayor Montandon stated that anyone having a yard or garage sale more than once per year was not having a yard sale, but was conducting a business.

Councilwoman Smith stated this ordinance brought the City into compliance with other municipalities. She advised Mr. Pasbrig he could ask Staff about the location of permits, use the website, or call the hotline number: 633-CNLV, or Business Licensing.

City Manager Rose stated once City Council decided on policy, he would develop administrative procedures on how the policy would be administered. This process would currently reside under Community Development, and Code Enforcement would be

administering it.

Councilman Eliason pointed out the ordinance made reference to private drives, as well.

Bob Borgersen thanked Code enforcement for coming to his neighborhood, and requested businesses be held accountable for the appearance of their areas, too.

James Sohns, 1000 Bonanza, Las Vegas, President of Nevada Car Owners Association, stated approximately one and a half to two years ago, they attempted to establish ordinances for the classic car community in the State of Nevada. They helped the City of Las Vegas and Clark County re-write ordinances for vehicles and conducted seminars for North Las Vegas, Clark County, Las Vegas, Henderson, and Boulder City on the classic car community and the laws.

The Nevada Car Owners Association appeared before the Legislative Council Bureau because of varying interpretations of the laws. Mr. Sohns presented a document which defined abandoned vehicles, junk vehicles, and nuisance vehicles from the Legislative Council Bureau.

He requested Ordinance Nos. 1861 and 1862 be put on hold due to contradictions in definitions with Nevada Revised Statutes definitions, and would like to meet with Sheldon Kain, the Manager of Code Enforcement.

<u>Anthony Hedges, 3640 Las Vegas Boulevard, North Las Vegas</u>, referenced Item "b" concerning vehicles left unattended on private property in excess of seven days. He asked how this would impact those who left town on vacation, got sick or were hospitalized, etc.

**Bob Borgersen, 4751 Possum Berry Lane, North Las Vegas,** commented in favor of the ordinance, but stated it would be better if the City required businesses to comply, as well.

Mr. Borgersen asked whether the new cell tower pole, previously approved, would be lit at night and Mayor Montandon responded if a flag was up, a light would be on it, as well. In addition, he asked whether a cell tower would be placed in Aliante, Seastrand, or El Dorado Parks and Mayor Montandon advised that as cell towers were needed, approval may be given for public places such as parks, but the City could not solicit placement of cell towers.

<u>Municipal Court Judge Warren VanLandschoot, 3806 Verde Way, North Las Vegas,</u> complimented Code Enforcement on cleaning up his neighborhood, with no citations issued. He stated the City and Court worked hard to make citizens happy. Fines would be levied with a sufficient amount of time to clean up an area. No one had been arrested for not paying code enforcement fines.

Councilman Eliason stated the City should make sure its own back yard was clean before it started imposing those laws on the citizens.

Councilwoman Smith further clarified the issue of removal of private vehicles from property and defined indications such as flat tires, cob webs, dust, inoperative broken windows, leaking fluids, broken glass, storage of items not commonly found in vehicles, cars sitting on

blocks, engine parts removed, absence of hood, doors, locks or ignition were indications vehicles would be in violation.

<u>Kevin Smith, 4014 Greenbridge, North Las Vegas</u>, believed the ordinance dealt more with beautification rather than nuisance. He moved to North Las Vegas because he did not want to live where Codes, Covenants and Restrictions dictated how he should live. He requested they reconsider this item at another a time.

<u>Kathy McManus, 3321 Helmsman Drive, North Las Vegas</u>, stated vehicles had been damaged in her neighborhood, including her own. Damage included flat tires, broken windows, and mirrors removed from cars.

Mayor Montandon stated this was a crime issue and not a code enforcement issue.
