BUSINESS

19. PRESENTATION BY CITY MANAGER GREGORY E. ROSE ON THE PROPOSED FISCAL YEAR 2004-05 WORK PLAN (GOALS AND OBJECTIVES) AND DIRECTION FROM COUNCIL AS TO HOW STAFF SHOULD PROCEED.

City Manager Gregory Rose stated in July of 2003, Council appointed him as Acting City Manager and directed him to focus on the following areas; vision, leadership and performance. Council would appoint Visioning Committee 2025 who would focus on developing and broadening the City Council's existing vision and provide recommendations to the Council for a 20-year period. Staff would work with this Committee and present their findings to Council.

Leadership Goals:

• To Strengthen City Staff and the Executive Team. City Manager Rose stated he would strengthen the Executive Team by identifying individuals who would lead and accept accountability for their Departments.

Performance Goals:

 To Establish Performance Objectives in Fiscal Year 2004-2005. City Manager Rose stated he would create objectives to measure the overall performance of the City.

Major Project Areas:

CITY MANAGER'S OFFICE

- Explore the Potential of a North Las Vegas Hot Air Balloon Festival.
- Explore Establishing a Non-Profit Agency to Coordinate the Taste and Tunes Festival. An organization existed that focused on fund-raising for this event throughout the year and could result in financial success for the City.
- Work with Businesses to Create Greater Summer Employment Opportunities for Teens. Teens were the City's customers through Parks and Recreation activities and through employment with the City or other businesses. City Manager Rose requested Council authorize Staff to work with the businesses to encourage them to employ teens during Summer and each City Department reserve one part-time, temporary slot for a teen for this season.
- Provide City Representation at the Legislative Session and Work with the Legislative Affairs Committee on Legislative Issues. Council approved the Legislative Affairs Platform for the February 2002 Session, and Staff would work toward its approval in Legislature.
- Develop a Financial Management Program for Staff. Human Resources would create a program to assist employees in managing their funds.
- Perform a City-Wide Cash Handling Audit. Policies and procedures were needed to minimize the possibility of theft within Departments who handle cash and credit cards.
- Provide the City Council with a Capital Improvement Plan that Addresses Community Needs. A program was presented to Council for Fiscal Year 2004-2005 and would also be presented for Fiscal Year 2005-2006.
- Present to the City Council a 20-Year Municipal Facilities Plan.
- Provide the City Council with an Annual Operating Budget. Staff recommended an annual operating budget that was financially sound and fiscally responsible for FY2004-2005 and this process would be repeated for 2005-2006.
- Provide the City Council with Quarterly Project Reports. Staff would provide Council with updates on projects assigned to them.
- Improve Street Maintenance Services. The Public Survey revealed improvement in this area was needed and Public Works would manage this effort.
- Develop a Strategy for Broadening Economic Development's Focus to Include

Foreign Company Recruitment. Staff sought authorization from Council to develop a strategy in establishing relationships with and recruiting foreign businesses to America and North Las Vegas in preparation for a change in the economy.

- Provide the Community with a Job Fair(s) Specifically Targeted for the Residents of North Las Vegas.
- Develop a Communications Model for the City and Centralize the Service. Staff
 requested approval to establish a committee to insure if any type of incident
 occurred that Police, Fire, Public Works and the Parks and Recreation Departments
 would be able to communicate with one another.
- Explore Processes for Lowering North Las Vegas' Crime Rate. The Police Chief had done an outstanding job this year, reducing violent crimes by 10%. There was a slight increase in property crime. Chief Paresi headed a task force that reviewed community outreach and other programs targeted to reduce crime.
- Explore Ways to Reduce the Property Tax Rate without Reducing Service Levels.
 The City's tax rate was higher than the other City in the Valley. Steps needed to be
 taken to reduce the property tax rate to make the City more competitive from an
 economic development perspective.

<u>Ed Lubbers, City's Special Counsel for the purchase of Craig Ranch Golf Course,</u> stated he conducted negotiations with the property owner. Attorney Lubbers stated the goal was to purchase Craig Ranch Golf Course, consisting of 132± acres, along with any associated water rights and certain personal property that related to the operation of the golf course.

The purchase price was the appraised value, determined by an appraisal conditioned by the City. The appraiser would be hired by the City based upon Federal Appraisal Standards and subject to review by the Bureau of Land Management (BLM) to determine its accuracy. Under Southern Nevada Public Lands Management Act, the BLM was authorized to reimburse the City for purchases of property to be used as parks, trails and natural areas. Attorney Lubbers did not anticipate the City fronting the money and being reimbursed because of the amount in money involved. This transaction would be coordinated at closing so funds could be utilized for the purchase. Attorney Lubbers stated the BLM or Federal Government would never be entitled to the Golf Course and could not use SNPLMA funds to take more or less than the appraised value, and could only pay appraised value. The agreement with the Seller was the City would pay appraised value. The Seller required an appraised value of not less than \$44 million; and would not be obligated to complete the sale if the appraised value were less than \$44 million. The closing was anticipated to occur three days after the BLM money was available, with a drop dead date of March 31, 2005.

Contingencies were in place for the benefit of the City: BLM money was available and verification of the water rights being purchased would be included as part of the appraisal. A Title Policy was required on the land and the City needed to reach an agreement with the BLM on the proposed perpetual use restriction the BLM stated they would put on this property. The City and BLM needed to agree on the restrictions on the use of any water rights that were purchased with their money. The BLM's position was if the City used their funds to purchase water rights, then the water had to be used on the land purchased. The City could not account for water, making sure that it went on a particular piece of property. The City would not want to continue to use wells, since it was a purveyor and had a water system. Further investigation into what BLM's position on this was needed. The Seller had put in the contingency that the purchase price would be not less than \$44 million, and the City was provided with two options to fund the difference should there be an inadequate appraisal. If the appraisal were over \$44 million and the BLM funding was less, the City had the option to provide the difference, but was under no obligation.

If this agreement were approved by the City Council, it would be submitted to the Sellers for execution.
