Mayor Montandon opened the Public Hearing.

Planning and Development Director Jory Stewart explained Staff had received a letter from the City of Las Vegas dated February 15, 2005, objecting to the increased height of the sign. They indicated the sign height would be unsightly and would result in visual blight for the immediate vicinity and would encroach into the view corridors of the existing residential development to the west. Staff appealed this item for further consideration by the City Council.

<u>Kristopher Munn, EN Engineering, 245 E. Warm Springs, Las Vegas,</u> represented the applicant, Wal-Mart, and Vision Signs on this project. He explained Wal-Mart's desire to keep the 60-foot pylon sign was due to the Decatur overpass as well as the fact there would be a lowering of the parkway. It was felt the-60 foot pylon sign would be the most beneficial.

Mayor Montandon asked Planning and Development Director Jory Stewart to reference the northwest corner and Costco, under development across the street, to determine the height of their signs. Director Stewart indicated a master sign plan would be required as part of the conditions of approval but the plan had not been submitted. A restriction, as a single occupant site, was one sign that was no more than 40 feet in height, unless a master sign plan and a use permit to exceed that height were submitted. Mr. Munn added that Wal-Mart had worked with Costco and they would probably construct signs similar to those on Summerlin Parkway.

Councilwoman Smith commented that since passing the sign ordinance that addressed heights, not one exception had been granted and Council had held firm to the standards.

Mayor Montandon asked Kristopher Munn to describe the picture he brought. Mr. Munn confirmed there were multiple signs around the property, some 10-foot signs, an 8-foot sign, the 60-foot sign on the overpass and a 40-foot sign on Decatur Boulevard. Councilman Eliason inquired as to the distance between the 40 and 60-foot signs; Mr. Munn responded it was approximately 300 feet.

Mayor Montandon closed the public hearing.

City Attorney Sean McGowan recommended the reasons for the denial be placed in the record.

Councilman Eliason felt there was adequate signage on the site and did not see any reason to grant the extension for the extra footage. Mayor Pro Tempore William Robinson agreed with Councilman Eliason's comment.

18. ACCEPTANCE OF THE LEGISLATIVE UPDATES FOR THE 2005 NEVADA STATE LEGISLATURE AND DIRECTION TO THE CITY MANAGER ON HOW TO PROCEED WITH BILLS PROPOSED IN THE STATE LEGISLATURE.

Lead Lobbyist Kimberly McDonald stated the first half of the legislative session was concluded and offered a legislative update. The status of the four North Las Vegas bills was given first.

AB 144 - Consolidated Tax Distribution Formula, was heard in February 2005 but did not survive. The issue was still alive and Ms. McDonald believed a significant stride was made in making the City's position well known. Other avenues were still being pursued.

AB 509 - City Charter Change - Flexibility for Ordinance Introductions, would allow Council to take action on ordinances no later than the second regularly scheduled meeting.

AB 11 - Red Light Cameras, died very early in the Assembly.

SB 473 - Red Light Cameras, continued to thrive with a hearing scheduled for April 12th. Chief Paresi co-presented the bill with Ms. McDonald and others. It passed out of the Senate Transportation and Homeland Security Committee. A positive and supportive editorial appeared in the Reno Gazette Journal April 17th.

SB 492 - Decrease Time Restriction for Unclaimed Property in Police Evidence Vault, was withdrawn because the language did not achieve the intent that was sought and would have resulted in significant opposition. The Nevada Chiefs and Sheriffs Association would work on the bill with the North Las Vegas legislative team during the interim session.

Lead Lobbyist McDonald reported on two additional bills the City of North Las Vegas was co-sponsoring with the Nevada League of Cities and Municipalities:

AB 22 (Legislative Clarification) - Authority of Library District to Recommend to City Council the Sell, Swap or Transfer of Donated Land, was doing very well. It passed out of the Assembly House unanimously on March 10th. It was in Senate Human Resources and the Education Committee awaiting a hearing date.

AB 89 (Enabling Language) - Alternative Municipal Facilities Designated for Voter Registration dealt with voter registration at alternative sites. City Clerk Karen Storms had testified and was expected do so again when the bill was presented. The bill was in the Senate Legislative Operations and Elections Committee at the time.

Other bills with significant impact on the City Council were as follows:

SB 148 (Expansion of City Council), proposed to expand the City Council from 4 to 6 wards (5 to 7 seats) and was withdrawn in early March of 2005 due to collaboration of the bill's sponsor and our City Council.

AB 197 (City Council Ward Vote & Election), proposed Council Members must be voted in by registered voters of the ward they represent. This passed out of the Assembly on April 18, 2005 and was in the Senate Government Affairs Committee. City Manager Rose testified in opposition of this bill and would do so again at a hearing scheduled for April 25, 2005 in Senate Government Affairs.

Other major legislation proposed by the City of North Las Vegas was highlighted by Ms. McDonald:

AB 165 - Planning Commission Continuances (Assemblywoman Marilyn Kirkpatrick - North Las Vegas Delegation), stated the limitation of two granted continuances only applied to an applicant on his/her behalf and not another person. Also, good cause must be shown in order to grant an additional continuance beyond the established limitation. This passed out of Assembly Government Affairs on April 11, 2005.

AB 231 - Sidewalks Mandate (Assemblyman Kelvin Atkinson - North Las Vegas Delegation), mandated local government construct, reconstruct and maintain sidewalks within one mile of public schools. Had it survived, this bill would have had a significant fiscal impact of \$25 million to construct and \$1.5 million to maintain. On April 11, 2005 an Assembly Joint Resolution was passed for the Southern Nevada Regional Planning Coalition to study the issue of safe walking paths for children.

AB 306 - Consolidation of Government. The City of North Las Vegas testified in opposition of this bill and it did not survive. An Assembly Joint Resolution was passed to conduct an interim study regarding the effects of consolidation.

AB 312 - Public Land Auctions. Assemblyman Sibley was working with Clark County on this bill. It would require the state and local governments to sell/dispose of land by public auction. This did not affect the City's exchange process and was in response to Clark County's issue regarding the land swap process at McCarran International Airport. Two appraisers, chosen from a rotating list, must value the land within six months of the auction and sealed bids would be opened at the auction.

AB 380 - Health District Bill, would reduce North Las Vegas representation from two to one member. Although there was opposition testimony, it was amended to pass out of Assembly Health and Human Services on April 12, 2005. This and future amendments would continue to be monitored. In response to a question from Mayor Montandon, Ms. McDonald stated Las Vegas and Clark County would have two representatives, whereas Henderson, Mesquite and North Las Vegas would have one.

AB 418 - More Cops Sales Tax, authorized the Clark County Commission to increase sales tax to employ and equip more police officers. This bill passed out of the Assembly Growth and Infrastructure Committee on April 14, 2005 on its way to the Senate.

AJR 9 - "3 Strikes" Ethics Bill, stated public officials convicted of three or more ethical violations must forfeit their offices. This bill passed out of the Assembly House on April 19, 2005.

SB 277 - Franchise Fees, would take away local government authority to impose franchise fees. Marvin Leavitt testified in opposition on behalf of North Las Vegas and the Urban Consortium. The bill failed to pass in Senate Commerce and Labor on April 14, 2005 but would be monitored should it resurface during the remainder of the session.

SB 262 - Billboards, established that if any public improvement noise abatement project performed by the City or County within the right-of-way of a freeway obstructed the visibility of a billboard, the owner of the billboard, upon the consent of the entity and the Nevada Department of Transportation, could adjust the height and angle to restore visibility or relocate to another area with no cost to the State or local government.

Councilman Buck asked how this bill would address landscaping that had been planted along the freeway by the State. Ms. McDonald replied this bill did not address the landscaping element but if the landscape did obstruct the visibility of the billboard, the owner would require authorization from the State and the City to relocate or make height adjustments. In response to an inquiry by Mayor Montandon, Ms. McDonald indicated the bill did require the owner to secure permission to make changes to the billboard. City Manager Rose said he understood the billboard companies had the ability to go to the various jurisdictions and request assistance. If the jurisdictions opted not to provide that assistance, they were not obligated to provide compensation to the billboard owner. City Attorney Sean McGowan stated the jurisdiction did have discretion as to whether or not they felt there was a visual obstruction. If the entity determined there was no obstruction, the billboard owner would then have the option to go to court to seek just compensation.

SJR 5 and 6 - TABOR (Tax Payers Bill of Rights), were Constitutional amendments that would limit appropriations and authorizations for expending, generating, creating or increasing public revenue. Marvin Leavitt testified in opposition to both of these bills on behalf of the Urban Consortium. Both TABOR issues were expected to resurface as 2006 initiative petitions.

SB 380 (Nevada Commission on Homeland Security)/AB 233 (Speaker Perkins) Homeland Security Bill, worked together and would reduce the Commission to 14 members and create a Finance Committee. The bills required that all homeland security funds come before the Commission to keep them informed and to clarify which documents were deemed to be confidential. The bills also mandated the formation of an interoperable statewide

communications system. Both bills were exempt and had passed out of their respective first house committees. Law enforcement, firefighters and first responders were working together to ensure the bills contained the appropriate language.

SB 83 - Open Meeting Law: Subjects of Discussion, contained a new requirement for the Board of Regents and other public bodies to allow subjects of closed meetings to attend the meeting and present testimony and written defense on their own behalf. This bill was amended, do passed out of the Senate Government Affairs Committee on April 11, 2005.

AB 267 - Open Meeting Law: Immunity, made members of a public body or people who testify before a public body immune to defamation lawsuits for statements made at public meetings. This bill was passed out of the Senate Government Affairs Committee on April 13, 2005.

SB 415 - Open Meeting Law: Board Confidentiality, required requests by boards be kept confidential until the public body determined they could be disclosed. This bill passed through the Senate House on April 19, 2005.

Finance Director Phil Stoeckinger provided a brief update on specific bills currently in the legislature:

AB 49 - Property Tax, set a 3% cap for residential properties and an 8% cap for commercial businesses which would provide a tax revenue increase of 9.7% in the upcoming year. The average had been about 18% for the previous five years but was reduced to13% when FY 2005-06 was included. An item of concern which still needed to be resolved in Carson City was the trailer bill addressing the tax increment of redevelopment revenues, which had not been taken into consideration when the legislation was passed. The impact on debt services was another issue to be considered.

SB 277 - Franchise Fees. The City of North Las Vegas received approximately \$11.2 million in franchise fees in Fiscal Year 2004-05 which equated to about 9% of the General Fund revenues. SB 277 was narrowly defeated but, according to our legislative team, there was a good chance this bill would come back. The impact of this bill would be a phase-out of the entire franchise fee of \$11.2 million, \$4.5 million in the first year.

AB 418 - Sales Tax Limitation, passed out of the Assembly Growth and Infrastructure Committee by a vote of 11 to 2. If passed, the tax would cover the entire cost of the police officers hired in FY 2005-06, including salaries and benefits.

Mayor Pro Tempore Robinson commented he believed some of the actions the legislators were taking were detrimental to cities. He felt the City should be run by the elected officials of the City of North Las Vegas. Mayor Pro Tempore Robinson further stated he felt the Legislature was being disrespectful of the City.

Mayor Montandon agreed with Mayor Pro Tempore Robinson's comments and felt a concerted effort was required to make the other entities understand there appeared to be a larger attack on the concept of home rule than seen in previous legislative sessions.

City Manager Rose indicated the City would continue to move forward consistent with the platform approved by the City Council.
