Glade Myler, Office of the Attorney General, advised the Nevada Emergency Management Assistance Compact (NEMAC) was created upon a mandate from the federal government that the entire state of Nevada have an intrastate agreement that dealt with all the political subdivisions in the state of Nevada and the rules for emergency management assistance from city to county, county to county, etc. This compact would set forth the rules for assistance from one entity to another and provided for reimbursement if requested from the assisting entity. The compact also provided for arbitration in the event problems with reimbursement should arise. Upon the adoption of the compact by all the political subdivisions, a committee would be created to handle any arbitrations. The committee would also be responsible for updating the compact.

Mr. Myler advised there were two typographical errors in the compact but they would be corrected upon the formation of the committee. He stated the state and all the counties had signed the compact and he requested Council approve adoption by the City of North Las Vegas.

"I am sure you are aware that the City has not been satisfied with your services. There have been many issues along the way, some that were addressed but many more that were not. There have been several meetings and countless phone calls between my staff and yours to resolve problems and complaints. The problems and complaints continued. The City's Workers' Comp Specialist, Pat Creevy, wrote to you on July 18, 2005, citing a great many unacceptable situations that had persisted throughout the first year of this contract. She received no response.

"On August 18, 2005, I wrote to you requesting that you call me to schedule a meeting for you and I to address the ongoing issues. I received no response from you but a message was left by your attorney, Sam Benham. I returned his call and indicated that I wished to speak with you. Since you have yet to respond to that request, I can only interpret this as evidence you do not wish to continue this association. I concur.

"Please accept this letter as 30-day notification to terminate the contract."

Acting Director Scalzi described several instances of incompetency involving stress testing of individuals on the tread mill. Complaints had been received from firefighters that they were not receiving their physical results. When informed of these problems, no response was received from Red Rock Medical Center.

Planning and Zoning Director Jory Stewart advised the Planning Commission recommended denial of the ordinance by a 4 to 3 vote. However, Staff drafted an ordinance that addressed Council's concerns.

Tony Celeste, 3800 Howard Hughes Parkway, Las Vegas, appeared on behalf of the applicant who proposed to develop 120 acres on Ann Road and Losee Road. The applicant had filed an application for a Planned Unit Development (PUD) that was filed for homes fronting Hammer Lane. Mr. Celeste advised that Celebrate Homes had received approval for lots fronting Hammer Lane across the street from the applicant's proposed project. The applicant requested the following language be added which stated applications filed prior to the adoption of the ordinance be exempt:

"Any Planned Unit Development application filed prior to April 1, 2006 shall not be subject to the requirements in Ordinance 2252."

When asked by Mayor Montandon for a legal opinion, City Attorney Sean McGowan responded Council would have more flexibility when approving applications if the language were not added. Director Stewart stated there was a provision in the drafted ordinance that allowed the Public Works Director some discretion over the proposed design when it involved houses facing a 60-foot street.

Councilman Buck commented since there were currently houses being built on Hammer Lane facing a 60-foot roadway across the street from the subject property, this application should be approved without adding the additional language to the ordinance. Director

Stewart agreed with Councilman Buck's comments and added approval would be subject to review by the Public Works Director and consideration of additional street-calming measures.

Councilwoman Smith felt since each application for projects with houses facing a 60-foot was separately reviewed by the Public Works Director, there was no need to insert the additional language into the ordinance.
