14. <u>RECEIVE A STATUS REPORT ON THE NEW CITY HALL AND DOWNTOWN</u> <u>AREA COMMAND PROJECT.</u>

Tom Brady, Principal Engineer, Public Works, reported on the new city hall and downtown area command projects. Mr. Brady stated the projects had been identified in the Capital Improvement Plan and the planning and programming effort had begun earlier this year when bonds had been sold for the funding.

Mr. Brady stated the key tasks included scope of development; consultant selection; master planning and conceptual design; final design and construction documents; construction; and commissioning.

Mr. Brady reported the scope of the overall project would include a civic plaza; a 21,000 square foot downtown area command center, with a 10,000 square foot training facility; and a new city hall.

Mr. Brady stated Staff had originally planned to have the site selection completed prior to the start of the master planning phase; however, with the purchase of the Silver Nugget Recreational Park, the site selection had not yet been determined.

Mr. Brady stated the first design agreement was expected in January 2007; however, the first task prior to the first design agreement would be the establishment of a five-person evaluation committee for the consultant selection process. The Assistant City Manager for Development and the project manager would be included on the committee.

Mr. Brady explained a detailed request for proposals had been issued in June 2006 to all interested parties to locate the best qualified firm for the project. He stated Staff received sixteen proposals and during the month of August, Staff had evaluated the proposals with the committee and compiled a short list of proposers. He stated the list had four candidates who were invited for interviews on September 15th to evaluate their experience with similar facilities. The committee developed the final rankings and selected the top-ranked firm.

Mr. Brady further explained the final selection took into account several factors including the proposals, the interviews and the perspective firms' design philosophies and ideas. He stated Staff conducted an exhaustive process with evaluation of these key indicators to find the best candidate who met the City's demanding requirements to guarantee a successful project. The final rankings had been prepared by the committee and presented to the City Manager at the beginning of October with selection of the top-ranked firm, Fentress

Bradburn/C&B Nevada.

Mr. Brady stated Fentress Bradburn was a nationally recognized firm who had demonstrated the ability to closely monitor and control schedules and costs, effectively manage multiple projects and specialized in the design of large municipal facilities as reflected in their portfolio. The portfolio included the Clark County Government Center, Jefferson County Government Center, Sacramento City Hall, City of Oakland Administration Buildings and many others.

Mr. Brady stated the consultant would be developing perspective building layouts and conceptual designs for both the Silver Nugget Recreational Park as well as the new city hall. He stated Staff would utilize these building layouts and conceptual designs to figure detailed estimates, and then discuss the composition of each facility to arrive at the best alternative. The best alternative would take into consideration the impact on current City operations during construction.

Mr. Brady advised Staff expected the master planning to take approximately six months after initiation of the contract. The completion of the master planning would be followed by a 12 month final design process. Finally, Staff expected another 18-20 months for the construction to be completed. Throughout the process, Staff would also be evaluating alternative delivery methods to accelerate the schedule and cut costs as much as possible.

Mayor Montandon asked City Manager Rose how closely the City had coordinated with the group who was buying the Silver Nugget Recreation Park. City Manager Rose responded he had met with the group about two weeks prior. He stated at that time he had advised them once a firm was selected by the City Council, the City's firm would coordinate with their firm to determine the type of design suitable for the space.

Mayor Pro Tempore Robinson asked Mr. Brady how many of the final ranking candidates had been local firms, and he responded all sixteen firms in the final ranking had partnerships with local firms. City Manager Rose stated Carter Burgess was a local firm and partnered with Fentress Bradburn. Mr. Brady stated Tate Snyder Kimsey and Bohlin Cywinski were local firms as well.
