# 15. ADOPTION OF THE PROPOSED 2008-2012 CAPITAL IMPROVEMENT PLAN IN

# THE AMOUNT OF \$1,144,567,618.

City Manager Rose stated the proposed 2008-2012 Capital Improvement Plan (CIP) had been presented to City Council on December 5, 2006. He stated the capital program had surpassed \$1 billion for the first time in the history of North Las Vegas.

City Manager Rose stated a summary by category for distribution of resources included community development 0.3%; flood control 7.3%; library 1.1%; municipal facilities 10.8%; parks and recreation 17.6%; public safety 8.3%; technology improvements 0.9%; transportation 27.7%; wastewater 22.0%; water 2.4%; and vehicles 1.6%.

City Manager Rose explained a historical analysis of the capital program indicated a significant increase since 2003-2007 when the CIP had been \$200,000,000.

City Manager Rose stated a summary of the proposed changes to the CIP since presentation to Council on December 6, 2006, included removal of the Pettiti Pool Replaster Project (to be completed in 2007); adjustment of the Clayton Street Project from \$1,348,600 to \$890,000; construction of an animal shelter to future years for \$14.7 million; the PSIS Technology Refresh moved from future years to fiscal year 2007-2008; the Culinary Expansion Project moved to future years; and completion of the shooting range improvements delayed to fiscal year 2010-2011.

City Manager Rose recommended Council adopt the 2008-2012 CIP with the proposed changes.
