As the members of the Friends of the North Las Vegas Library District had not arrived, Chair Smith went on to other items on the agenda.

### 7. <u>District Library Director's report</u>

Director Laruy reported that she had received a Correction Action Order from Clark County's Air Quality Division for the library land on Alexander. The order stated that they had observed dumping, parking, vehicular travel and stock piles of dirt and rocks. She asked for and was given an extension to complete the work. The property is being cleaned up by City crews and a water pallative will be applied after clean up. A fence and gate were also installed.

Director Laruy informed the Board that 38,000 surveys, to ascertain what residents want in the new library, were sent in the July water bills to customers in the area near Aliante. Thus far she has received 160 responses.

She further reported that she has been involved with the City's Visioning Committee.

Work on the Aliante Library is moving smoothly. The architects are working closely with the City's engineers and the library staff.

### **PUBLIC FORUM**

**Norman Simpson, 3011 Asher Lane, North Las Vegas, NV 89032,** questioned the decision by the Board to build a library at the Aliante site rather than the Alexander site. Additionally, asked why North Las Vegas spends far below the national average per capita on library services and materials.

Marlene Simpson, 3011 Asher Lane, North Las Vegas, NV 89032, stated she felt the Board was forgetting their old friends in the area of the Alexander site in favor of new ones at Aliante.

Alanna Simpson, 3011 Asher Lane, North Las Vegas, NV 89032, said that it looks like the Board is catering to the more affluent neighborhoods.

Andrew Simpson, 3011 Asher Lane, North Las Vegas, NV 89032, stated that there are numerous schools in North Las Vegas, but not enough libraries to serve their needs.

Andrea Simpson, 3011 Asher Lane, North Las Vegas, NV 89032, said she agreed with the other members of her family.

Chair Smith went over some of the reasons that the decision was made to build the library on the Aliante site. She said that she hopes to be able to partner with a senior center to construct a library on the Alexander site.

Both she and Trustee Robinson said they are still committed to building a library on the Alexander site.

Trustee Robinson left at 5:25 p.m.
