2. Review of Library District financial projections.

ACTION: PRESENTATION GIVEN

Finance Director Phil Stoeckinger distributed updated Library Fund projections that illustrated it would be five or six years before the Library District would have the financial capability to operate another new library. He said there are two reasons. One, as 98% of the District's funds are from property tax, the recent property tax cap will have a big impact. Two, the North Las Vegas Library District is the only library district that does not receive a portion of the Consolidated Tax. In FY 2005/2006 Boulder City Library District will receive over \$500,000; Henderson Library District will receive over \$2.2 million; Las Vegas-Clark County will receive over \$18 million.

Trustee Montandon asked for an explanation of why our Library District does not receive the consolidated tax.

Director Laruy explained that when the North Las Vegas Library District was created in 1993, the Legislature allowed the creation with the caveat that any new entity would not share in the SCCRT, which is now the Consolidated Tax. The City attempted to have that changed in the following Legislative session to no avail.

Trustee Robinson said it was time to try again.

Finance Director Stoeckinger said that Enterprise and Summerlin Townships were allowed to receive a portion of the Consolidated Tax since that time and that would strengthen our case.
