Mr. Garlow said that the scheduled completion date for the building is February 25, 2006 and that it will take an additional month to move in shelving, furniture, computers, etc.

Chair Buck asked if the gray color of the exterior block will change. Director Laruy replied that there would be a slight change of color with the addition of the anti graffiti coating. Mr. Garlow stated that the colors and materials comply with the Aliante color standards. Chair Buck said that most of the other buildings in Aliante were a brownish color, so she was surprised that the library is gray.
