City Attorney Carie Torrence stated it had been a pleasure serving as the City Attorney within the past year. Last year's goal for the City Attorney's Office was to provide a top quality mid-size law firm which she believed had been accomplished. She reported that the highlights of the accomplishments over the past year were broken down into three divisions; development, litigation and criminal. All three divisions had made substantial improvements over the past year focusing on internal customer service which enacted follow up performance measures that improved turnaround time of the document and improved the quality of legal services being provided to the internal city departments. The City Attorney's Office, as a group, had become more pro-active by attending the majority of department meetings and began an extensive training program with their attorneys dedicating over 200 hours of training to city departments such as; harassment issues, escrow instructions and training to the Police and Detention Academy and Police Department Community Services Group, as well as participation in many other internal teams within the City. The litigation division saved the City within the calendar year 2007 \$376,000 in attorney fees that would have been charged to the Self-Insured Fund by handling and increasing the number of cases in-house. This amount was expected to increase to \$450,000 for fiscal year 2007-2008. The criminal division had performed a great deal of time on community outreach, especially in the areas of domestic violence in the community.

Councilwoman Smith commented that City Attorney Torrence's addition to the City Attorney's Office had been of great benefit to the City of North Las Vegas and she exceeded their expectations. She thanked City Attorney Torrence for her dedication to work and contribution to the success of the City. She stated that being nominated by her own peers to receive the National Award from the American Bar Association spoke very highly of her and commended her for the great work. She also stated the City of North Las Vegas was fortunate to have her to represent them as she was one of the best attorneys in town.

City Attorney Torrence commented that she had a great team working with her and wanted to thank all City Attorney staff for their support and help. She especially thanked Nick Vaskov for his guidance and support.

Mayor Montandon spoke briefly on how the Legislature passed a new rule where performance evaluations must be discussed in public view and this was the first time he had witnessed someone receive a round of applause at a performance evaluation. He appreciated and thanked City Attorney Torrence for all her accomplishments and the great work done.

Councilwoman Smith stated last year City Council purposely set City Attorney Torrence's salary well below range to provide her the opportunity to prove herself and she certainly had demonstrated to be the right person for the job.

However, if anyone in the public wanted to discuss the date of February 20<sup>th</sup>, they were welcome to speak tonight but no action would take place.

<u>Louis R. Reimer, 4012 Ricebird, North Las Vegas, Nevada</u>, stated he lived a quarter mile from this development and was interested to hear what would happen with this item.

Mayor Montandon explained to Mr. Reimer that Council appreciated their involvement but

when Council introduced an ordinance, the law was very specific about providing the citizens with plenty of notice.

Mr. Reimer reported that on January 15<sup>th</sup> at a community meeting, he and members of his community had met with the attorneys from Opus and had been informed Opus would make a presentation that included their plans. The community felt that they should know Opus' plans before the item went for discussion at the next meeting; therefore, he requested that Council consider adding a provison in the ordinance after they hear the Opus presentation.

Mayor Montandon stated he strongly encouraged Opus to hold a presentation before February 20<sup>th</sup> to make sure all residents were aware of the plans. If for any circumstances, a presentation could not be held before February 20<sup>th</sup> Council would then hold the meeting until a later date and would make every effort to put out notices in advance to all residents.

Bonnie Stanley, 6127 Sage Hills, North Las Vegas, Nevada, commented fifty years ago the City of North Las Vegas did not even exist and stated she had a problem with the legal process. She spoke about the letter of the law being followed and notice given to all residents affected by the zoning change. Those directly affected were not given notice because they lived further than what was required to be noticed prior to a zoning hearing. She felt that while the letter of law was followed the intent of law was circumvented.

Mayor Montandon stated Council shared the concerns of the citizens, but the letter of the law had changed numerous times over the years and became more expansive. Staff notified all citizens through various resources such as public notices, newspapers, internet and mailing. Additional notices were mailed to those who lived within a certain distance radius.

Ms. Stanley further discussed that residents were not even notified of any prior re-zoning changes.
