2. UN-101-04 (MARCELLO'S TAVERN); AN APPLICATION SUBMITTED BY CARL D. MARCELLO ON BEHALF OF THE CLARK COUNTY DEPARTMENT OF AVIATION & MARCELLO AIRPORT CENTER, LLC, PROPERTY OWNERS, FOR AN EXTENSION OF TIME FOR A USE PERMIT IN A C-2 GENERAL COMMERCIAL DISTRICT TO ALLOW THE "ON-SALE" OF ALCOHOLIC BEVERAGES IN CONJUNCTION WITH A RESTAURANT/TAVERN ON PROPERTY LOCATED AT 2580 NORTH RANCHO DRIVE.

Mayor Montandon opened the Public Hearing.

Acting Planning and Zoning Director Frank Fiori explained the use permit for the restaurant/tavern was approved in July 2004. An amended use permit which revised the location was approved in December 2004. A one-year extension of time was approved in September 2005. An additional one-year extension of time was found to be necessary and approval was recommended.

<u>Jennifer Lazovich, Kummer Kaempfer Bonner Renshaw and Ferrario, 3800 Howard Hughes Parkway, Las Vegas</u>, was present on behalf of the applicant.

Mayor Montandon closed the Public Hearing.

- 2. THAT THE RESTROOMS BE LOCATED SUCH THAT PATRONS ARE NOT REQUIRED TO GO THROUGH THE BAR AREA TO ACCESS THOSE FACILITIES.
- 3. THAT THE FLOOR AREA OF THE BAR SHALL NOT EXCEED 50% OF THE TOTAL PUBLIC RESTAURANT FLOOR AREA.
- 4. APPROVAL OF A DRAINAGE STUDY IS REQUIRED PRIOR TO SUBMITTAL OF THE CIVIL IMPROVEMENT PLANS.
- 5. CLARK COUNTY REGIONAL FLOOD CONTROL DISTRICT (CCRFCD) CONCURRENCE WITH THE RESULTS OF THE DRAINAGE STUDY IS REQUIRED PRIOR TO APPROVAL OF THE CIVIL IMPROVEMENT PLANS.
- 6. CITY OF LAS VEGAS CONCURRENCE WITH THE RESULTS OF THE DRAINAGE STUDY IS REQUIRED PRIOR TO APPROVAL OF THE CIVIL IMPROVEMENT PLANS.
- 7. ALL KNOWN GEOLOGIC HAZARDS SHALL BE SHOWN ON THE SITE PLAN AND THE CIVIL IMPROVEMENT PLANS. SUBSEQUENT IDENTIFICATION OF ADDITIONAL HAZARDS MAY SUBSTANTIALLY ALTER THE ORIGINAL SITE PLAN.
- 8, APPROVAL OF A TRAFFIC STUDY IS REQUIRED PRIOR TO SUBMITTAL OF THE CIVIL IMPROVEMENT PLANS.
- 9. THE CIVIL IMPROVEMENT PLANS FOR THE PROJECT SHALL INCLUDE SCHEDULE 40 PVC FIBER OPTIC CONDUIT ALONG RANCHO DRIVE AND CAREY AVENUE.
- 10. THE NUMBER OF DRIVEWAYS AND THEIR LOCATIONS ARE SUBJECT TO REVIEW AND APPROVAL BY THE CITY OF NORTH LAS VEGAS TRAFFIC ENGINEER AND MUST MEET THE STANDARDS SET FORTH IN NORTH LAS VEGAS MUNICIPAL CODE 17.24.130. CONFORMANCE MAY REQUIRE MODIFICATIONS TO THE SITE.

- 11. ROUNDABOUT DESIGN SHALL CONFORM TO THE FEDERAL HIGHWAY ADMINISTRATION'S ROUNDABOUTS: AN INFORMATIONAL GUIDE DESIGN CRITERIA AND IS SUBJECT TO APPROVAL OF THE CITY TRAFFIC ENGINEER.
- 12. COMMERCIAL DRIVEWAYS ARE TO BE CONSTRUCTED IN ACCORDANCE WITH CLARK COUNTY AREA UNIFORM STANDARD DRAWING NUMBERS 222A AND 225, WITH MINIMUM WIDTHS OF 32 FEET AS MEASURED FROM LIP OF GUTTER TO LIP OF GUTTER.
- 13. THE PROPERTY OWNER IS REQUIRED TO GRANT A ROADWAY EASEMENT FOR COMMERCIAL DRIVEWAY(S).
- 14. THE PROPERTY OWNER IS REQUIRED TO SIGN A RESTRICTIVE COVENANT FOR UTILITIES.
- 15. THE EXPIRATION DATE FOR THE SPECIAL USE PERMIT SHALL BE MAY 7, 2009.

<u>Hughes Parkway, Las Vegas</u> stated the tavern was located in retail building no. 8 of the development, and added they had recently been approved for another restaurant at the site.

- 2. THAT UN-23-08 IS SITE-SPECIFIC AND NON-TRANSFERABLE.
- 3. THAT UN-23-08 COMPLY WITH ALL APPROPRIATE CONDITIONS OF SPR-41-06 AND T-1292.
- 4. A MINIMUM TWO BICYCLE PARKING SPACES SHALL BE PROVIDED WITHIN 15 FEET OF THE BUILDING. THE BICYCLE PARKING SPACES SHALL NOT BE LOCATED WHERE THEY WOULD INTERFERE WITH REQUIRED LANDSCAPING OR PEDESTRIAN ACCESS.
- 5. EXTERIOR ROOF LADDERS ARE NOT ALLOWED. ACCESS TO THE ROOF SHALL BE FROM WITHIN THE BUILDING.
- 6. THE COLORS, DESIGN AND MATERIALS SHALL BE CONSISTENT WITH THOSE APPROVED FOR THE SHOPPING CENTER UNDER SPR-41-06.
- 7. FOUNDATION LANDSCAPING, OR A SUITABLE ALTERNATIVE, SHALL BE PROVIDED ALONG THE SOUTH AND WEST SIDES OF THE BUILDING WHERE THEY ABUT PARKING STALLS OR DRIVE AISLES. WHEELSTOPS MAY BE REQUIRED WITHIN THE PARKING SPACES THAT ABUT THE BUILDING.
- 8. THE TRASH ENCLOSURE IS REQUIRED TO MATCH THE BUILDING IN DESIGN, COLORS AND MATERIALS, INCLUDING A ROOF AND SOLID METAL GATES HUNG APPROXIMATELY 8 INCHES ABOVE THE GROUND.
- 9. THE SITE PLAN SHALL BE REVISED TO IDENTIFY A MINIMUM 20-FOOT SETBACK FROM THE REGIONAL TRAIL.

- 10. THE 20 FEET OF LANDSCAPING WITHIN THE FRONT SETBACK AREA (SOUTH OF THE REGIONAL TRAIL ALONG DORRELL LANE) MAY BE DESIGNED AS A "HARDSCAPE" AREA WHICH WOULD FACILITATE OUTDOOR SEATING/DINING, DECORATIVE PAVERS, TREE WELLS WITH GRATES AND APPROPRIATE LIGHTING, SUBJECT TO REVIEW AND APPROVAL BY STAFF PRIOR TO THE ISSUANCE OF A BUILDING PERMIT.
- 11. IF THE TAVERN RESTAURANT IS CONSTRUCTED PRIOR TO OTHER ADJACENT USES, THEN A SUFFICIENT NUMBER OF PARKING SPACES SHALL BE PROVIDED IN COMPLIANCE WITH THE REQUIREMENTS SET FORTH IN THE ZONING ORDINANCE AND SAID PARKING SPACES, PARKING LOT LANDSCAPING AND LIGHTING SHALL BE PROVIDED PRIOR TO THE ISSUANCE OF A CERTIFICATE OF OCCUPANCY. OUTDOOR SEATING / DINING WOULD REQUIRE ADDITIONAL PARKING.

Acting Planning and Zoning Director Fiori explained Ordinance No. 2436 reduced minimum lot sizes in R-1 and R-2 districts, increased maximum density to comply with the 2006 Comprehensive Plan, proposed changes to the small lot design guidelines and addressed frequent waivers to help streamline the review procedure for small lot projects.

Ordinance No. 2437 created the Residential Design Incentive System (RDIS) to help implement some of the ideas expressed in the Comprehensive Plan which acknowledged the need for greater density and flexibility for better integrated communities. It was to be used as an alternative to current regulations and did not replace current regulations.

Ordinance No. 2438 contained the procedures for the Residential Design Incentive System, for which final action was determined by the Planning Commission.

The Planning Commission recommended approval of all three ordinances.

Councilman Eliason was concerned about residents who originally bought homes in R-1 districts and asked if there would be notifications of zone changes. Acting Planning and Zoning Director Fiori said there were no notifications or public hearings. Planning and Zoning Manager Marc Jordan clarified under the RDIS system an R-1 density zone could not change to an R-2 density zone without a public hearing.
