Sergeant Clint Ryan of the Police Department Internal Affairs Bureau explained that the applicant, Ms. Sadiq requested a business license for an ice cream truck. The license was denied based on her driving history.

Ms. Sadiq explained that she had been driving an ice cream truck since 2001 and received her Nevada driver's license in 2002. She explained that the officer told her she had a suspended driver's license.

Mayor Montandon questioned whether there was a discrepancy between the motor vehicle report obtained by the Police Department and that of the applicant. Sgt. Ryan explained there was a discrepancy. Sgt. Ryan explained the one attached by the applicant was never seen before and was from the Department of Motor Vehicles which showed a current valid license and nothing listed under convictions. The one obtained from the Police Department showed several violations dating back to 1995. Ms. Sadiq explained that she relocated to Nevada in1999 from Utah. Mayor Montandon questioned whether the violations since 2005 were moving violations. Sgt. Ryan confirmed they were.

Councilwoman Smith questioned whether the moving violations were with the ice cream truck or with both the truck and personal vehicles. Ms. Sadiq explained the moving violations were not received with the ice cream truck. Councilwoman Smith explained she was concerned about protection of the children but said Ms. Sadiq had no ice cream truck violations in the past five years other than a current violation that was unknown.

Mayor Pro Tempore Robinson recommended granting the work card with a review in one year.

Councilwoman Smith questioned City Attorney Torrence if the City were able to request a review in one year. City Attorney Torrence explained the Police Department would review the applicant's driving record after one year and make a recommendation to Council.

Acting Planning and Zoning Director Frank Fiori explained the Development Agreement was originally approved by Council in May, 2006. Major modification amendments were proposed. The site designated for Regional Commercial with resort overlay at the northwest corner of Losee Road and the 215 Beltway would be expanded, a portion of the land designated for Medium-High Density Residential and Mixed-Use would be converted to Regional Commercial and parcel 3.14 would be converted from Medium-Low Density Residential to Medium Density Residential. He also explained there were several text amendments proposed to the development agreement, development standards and design guidelines to be consistent to the proposed changes to the land use plan which included development parcel number redesignations, revisions to the shops, village and neighborhood area map and other minor modifications. Staff recommended approval.

<u>Chantelle Pop (no address given)</u>, spoke on behalf of Lisa Mayo with whom she worked to get SB208 passed which would limit casinos in neighborhoods. She read a letter from Lisa Mayo into the record opposing the ordinance which would expand the gaming overlay.

## Bob Gronauer, 3800 Howard Hughes Parkway, Las Vegas, represented Park Highlands.

Mayor Montandon questioned the modification of the building height to allow for a 440-foot tower. Mr. Gronauer explained that when the development agreement and development standards and guidelines were negotiated it allowed for parcel 4.09 to have a height of up to 440 feet. He explained the rationale was because the Binion's side had two towers and their location on the south side of the 215 and Losee Road had a height of 440 feet. The modification change was that the parcel number was changed from 4.09 to 4.09a. The height of the parcel was already approved.

Mayor Pro Tempore Robinson questioned whether a casino site was being presently approved. Mr. Gronauer stated no.

Councilman Eliason questioned whether there was a desire to come forward with a gaming overlay. Mr. Gronauer explained it was a request to move forward with major modifications based on a casino application and commercial and residential public facility park areas being changed around.
