Ms. Roberts explained the application was for a deferred deposit business located in a large commercial complex on Ann Road and Simmons Street that also had a Wal-Mart store. The Moneytree store met the size and distance requirements for the special use permit. She noted Moneytree had a policy to avoid large signs and did not announce its payday loan or check cashing services on its exterior signage. She stated Moneytree was a reputable business with a clean record that participated in charities and had worked with Nevada Legislature to ensure its professionalism.

Mayor Pro Tempore Robinson clarified that although payday loan and check cashing services were not advertised on the exterior, the establishment offered those services.

Councilwoman Buck noted there was a check cashing service within the neighboring Wal-Mart store.

Councilwoman Smith stated while the City's view of check cashing establishments was not entirely favorable, the company met all the conditions for approval.
