Planning and Zoning Director Jory Stewart reported Planning and Zoning recommended approval of both applications because Staff felt the employment land use designation did not fit the intent of the comprehensive plan and the neighborhood commercial designation was more suitable. The Planning Commission recommended denial.

Gary Leobold, Leobold and Brown, 2592 Canadian Goose Circle, Henderson stated the requests for the comprehensive plan amendment and zone change were based on the project they wanted to develop on a five-acre parcel containing 35,000 square feet of retail and service uses in three buildings. A bank and child care facility were among the potential

businesses. The applications went before the Planning Commission because there was a requested waiver on the site plan review. He felt the neighborhood commercial designation was appropriate for the area.

Councilman Eliason confirmed a use permit had previously been approved to allow another bank. Councilwoman Buck asked why it was stated in the Staff Report the employment center designation was no longer appropriate and a change to neighborhood commercial was recommended. Director Stewart explained code was amended to allow additional uses for a nearby parcel, which would be enhanced by changing the current parcel to neighborhood commercial.

Planning and Zoning Director Stewart stated development of the site had been challenging. Staff recommended denial of both applications due to the proximity of industrial use in the area and the addition of residential development. The Planning Commission recommended approval.

George Garcia, 1711 Whitney Mesa Drive, Suite 110, Henderson displayed the site. He said the area had changed from industrial to medium density residential. The parcel in question was in close proximity to schools and employment. The surrounding industrial uses made it inappropriate for detached houses, and it was felt apartments were a better option. The proposed project accommodated 20 units per acre and had been designed by Celebrate Homes to work with the surrounding parcels. It was a challenging site and Mr. Garcia felt it could remain vacant if the application was not approved.

Mayor Montandon agreed there were no other viable uses for the site. Mayor Pro Tempore Robinson stated he did not like the idea of putting apartments at the site because part of it faced a school, however, in this case he felt it was the only option.

Human Resources Director Lira reported Staff recommended approval of the medical, dental and vision contracts as proposed. Mayor Pro Tempore Robinson confirmed with Director Lira all three plans were portable.

Director Lira explained the current contracts were due to expire. City Manager Rose had appointed a citywide Health Care Insurance Committee consisting of representatives from various departments which included employees, management and union representatives, as well as representatives of the City's insurance broker, Branch Hernandez and Associates. A subcommittee and the City's Legal Department had conducted extensive reviews of plans which were submitted. The recommendation was to accept Anthem Blue Cross Blue Shield for medical insurance. No referrals were needed, there were no deductibles with in-network providers and the co-pay was \$10, which was identical to the current plan. Ninety percent of doctors in southern Nevada and all the hospitals in southern Nevada were in the network. In addition, Blue Cross Blue Shield partnered with doctors and hospitals in other states. There were excellent wellness programs and many quality of care programs. In addition, there was a local office, and the City's Legal staff participated in the appeals board. In-network coverage was unlimited. There was a 10 percent savings as compared to the current medical plan premium.

The recommendation was to continue with the existing dental insurance carrier. There was a 5 percent increase in premiums, however, benefits were enhanced and the annual maximum was raised from \$1,000 to \$1,500.

The recommendation regarding the vision plan to contract directly with Vision Service Plan (VSP) afforded the City a 55 percent decrease in premium rates. In addition, lenses were covered every 12 months instead of 24 months.

In total, there was a 9 percent reduction in premium costs, which was a savings of \$828,896. On-site meetings and open enrollments were scheduled for implementation of the plans on February 1, 2008.

<u>Aubrey Branch of Branch Hernandez and Associates</u> commended the City on the process of selecting insurance companies.
