3. MONTHLY STATUS REPORT ON THE PROPOSED RENTAL REHABILITATION PROGRAM.

Community Development Director Jacque Risner presented a plan to initiate a Rental Housing Inspection Program. Community Development would monitor the program and Neighborhood Services along with the Code Enforcement Division would be involved. Director Risner stated the Rental Housing Inspection Program would become the proposed property maintenance ordinance which the Redevelopment Agency had cited as an objective.

Statistics obtained from the 2000 Census Data reported approximately 17,000 rental units existed in North Las Vegas with approximately 9,100 multi-family rental units of duplexes. There were approximately 8,000 single family rental homes.

An estimated 75% percent of all low income housing within the valley existed in North Las Vegas. Statistics showed similar communities had discovered approximately one in ten rental units were substandard and in need of major repair. The statistic could be higher in North Las Vegas due to the age of many rental units.

The current inspection program consisted of inspections conducted when tenants complained. One building inspector was assigned to investigate tenant complaints. The inspector only issued citations when a health and/or safety violation was discovered. The weakness of the current inspection program consisted of no established standard for rental units, limited resources had been allocated to the program, a lack of manpower existed and the current codes lacked a systematic enforcement program of inspection. The current system of housing codes and code enforcement as implemented and prosecuted gave little incentive to rental owners to comply with the law or to avoid deterioration and decline.

The proposed plan would establish a minimum standard for all rental units. Inspections of rental units would occur once every two years on an as needed basis. The Finance Department had stated they could identify the rental units to aid the program. The appropriate resources would be allocated for inspections to be performed. The program would integrate with Community Development Block Grants (CDBG) and Home Investments Partnership Act (HOME) funds.

Board Member Montandon questioned if the statistic which stated 75% of all low income housing within the valley existed in North Las Vegas was a recent statistic. Director Risner stated the statistic had been obtained from a study possibly completed in 1998.
