AYALA ON BEHALF OF G & M DEVELOPMENT, PROPERTY OWNER, REQUESTING A SITE PLAN REVIEW IN A C-2 GENERAL COMMERCIAL DISTRICT TO ALLOW A 10 FOOT SETBACK, WHERE A 20 FOOT SETBACK IS REQUIRED, FOR PROPERTY GENERALLY LOCATED AT THE NORTHEAST CORNER OF LAS VEGAS BOULEVARD AND CAREY AVENUE.

Tim C. Ayala, 4600 Sunset Road, Las Vegas, Nevada, stated the land would be hard to develop due to the topography. He thanked Acting Community Development Director Kenny Young, Staff and multiple City departments for their work and stated he was prepared to answer questions.

Board Member Smith stated she was concerned with the item being brought before the Redevelopment Board as an information only item and added she felt the Board should be included in all decision making processes in the future.

Chairman Eliason questioned if date palms would be planted along Las Vegas Boulevard. Mr. Ayala responded yes. Chairman Eliason asked if Building D would prevent traffic flow into the parking lot. Mr. Ayala answered yes, because of the right-of-way issue. Building D had been grand-fathered in and encroached on the traffic of Carey Avenue. Chairman Eliason questioned when construction would begin. Mr. Ayala stated construction would begin right away. His client would be meeting with the Nevada Department of Transportation (NDOT) and the Citizen Area Transit (CAT) in the immediate future. The survey and grading had been started but plans had not been submitted to City Engineering at the current time.
