3. <u>DISCUSSION AND POSSIBLE ACTION REGARDING RESCISSION OF DENIAL OF UN-18-06 (RAINBOW BRIGHT); AN APPLICATION SUBMITTED BY LYDIA CARTER ON BEHALF OF VEGAS VIEW CHURCH OF GOD IN CHRIST, PROPERTY OWNER, FOR A USE PERMIT IN AN R-A/FA REDEVELOPMENT AREA/FOCUS AREA SUBDISTRICT TO ALLOW A CHILD CARE CENTER, ON PROPERTY LOCATED AT 1906 GLIDER STREET, A.P.N. 139-23-310-030. (IF DENIAL RESCINDED: SET PUBLIC HEARING FOR JULY 5, 2006)</u>

John Delikanakis, Snell & Wilmer, 3800 Howard Hughes Parkway, Las Vegas, appeared on behalf of Jerry's Nugget and opposed the rescission of the Agency's decision to deny the applicant's request for a use permit. Since the request had been denied at a previous meeting, Mr. Delikanakis requested an explanation as to why the second public hearing was scheduled. Board Member Montandon advised he had requested the item be put on the agenda for a re-hearing because he wanted an opportunity to visit the site of the proposed day care center to become familiar with the issues presented by both sides.

Peter Demangus, 1821 North Las Vegas Boulevard, North Las Vegas, stated for the

record that he had previously attempted to purchase the church; however, no decision had been made regarding that transaction. He offered to assist Rainbow Bright in locating an alternative site for their day care.

Mr. Delikanakis explained that, although Vegas View Church was a nonprofit entity, the Rainbow Bright day care center was a for profit business which would be subleasing space in the church. He felt this issue should be further addressed by the Planning Commission.

Vice Chairman Buck felt there should be no further discussion and the question was whether or not this issue should be re-considered. Chairman Eliason agreed the public hearing was strictly to hear new information. Vice Chairman Buck asked City Attorney Sean McGowan if this was considered a public hearing to which he responded in the sense that the meeting was an open meeting, it was a public hearing. Vice Chairman Buck requested a decision from the Agency as to whether the item should be re-considered or sent to the Planning Commission. Chairman Eliason stated the public hearing was set only for the purpose of hearing new information.

<u>Jerald Mason, 1906 Glider Street, North Las Vegas,</u> stated he had received information that Staff had not fully informed the Agency of all the conditions that were met to obtain the special use permit. Chairman Eliason advised Mr. Mason that all the necessary information had been presented to the Agency.

Board Member Smith agreed a day care center would be beneficial in the Redevelopment Area; however, she suggested another site be chosen and asked Redevelopment Manager Larry Bender if Staff could offer some assistance toward that goal. Manager Bender responded there were resources available to assist the applicant if directed to do so by the Agency.

When asked by Board Member Robinson what type of Agency assistance would be available, City Manager Rose responded this business would be treated the same as any other business requesting assistance from the Redevelopment Agency to establish a for profit business.

At the suggestion of Board Member Montandon, City Manager Rose stated Staff would act as facilitator to assist in a smooth transaction for the day care facility.

Board Member Buck advised she was not in favor of re-hearing the item and felt the location of the proposed day care center was inappropriate. She encouraged the applicant to contact other churches in the area to secure a more appropriate location.

Board Member Robinson stated he did not object to bringing the item back for further discussion.

Board Member Smith stated that, while she supported a day care center, she was not in favor of the proposed location. She agreed that the City should assist the applicant in securing an alternative location.
