### 3. <u>AN UPDATE BY THE MONTECITO COMPANIES REGARDING THE CHEYENNE</u> <u>POINTE REDEVELOPMENT PROJECT.</u>

Michael Townsend of the Montecito Companies, described the Cheyenne Pointe Redevelopment Project, an eighty-nine thousand square foot shopping center located at the southeast corner of Cheyenne Avenue and Civic Center Drive at a cost of almost \$21 million. The project was 69.75% pre-leased. The project will be completed mid-January, 2007 with a majority of the tenants opening and operating by March, 2007. Mr. Townsend gave a brief history of the acquisition of land for this project and the purchase of a new,
