## **BUSINESS**

5. <u>DISCUSSION AND POSSIBLE ACTION FOR THE ACQUISITION OF CLARK COUNTY ASSESSOR'S PARCEL NUMBER 139-23-211-067 IN THE APPROXIMATE AMOUNT OF \$110,000, FOR PROPERTY LOCATED WITHIN THE DOWNTOWN BEAUTIFICATION AREA, WITHIN THE "LAKE MEAD BOULEVARD ISLAND" AREA.</u>

Redevelopment Agency Manager Larry Bender explained this was a request to acquire a vacant parcel located at Lake Mead Boulevard and Glider Street. The Redevelopment Agency requested \$110,000; \$98,000 for the purchase itself, which was the appraised price and \$12,000 estimated closing costs.

Redevelopment Agency Manager Larry Bender explained this was a request for \$99,000 in reimbursable expenses to the new owners of the Silver Nugget Casino. The Silver Nugget Casino intended to spend \$1,747,000 of their own private sector money in the first phase and in return the Redevelopment Agency would be committing to a reimbursement of \$99,000 for exterior facade improvements.
